

As the operators of the LANDED Hiring Software website, ("the website") Onboard Staffing Solutions Ltd, registered in Northern Ireland with Company Registration Number NI620623 and having its address at 28 The Promenade, Portstewart, BT55 7AE ("We", "Us") is committed to protecting and respecting your privacy. This Policy ("Policy") together with our Terms of Use and other documents referred to on it, set out the basis on which any Personal Data collected from you, or that you provide to us will be processed by us.

We aim at all times to process and collect your data lawfully, transparently, fairly and without adversely affecting your rights as a Data Subject (as defined below). Please read the following carefully to understand our practices regarding your personal data and how we will treat it.

Please note:

By giving your consent, you are accepting and consenting to the practices describes in this policy. If you do not give your consent, please navigate away from the Website. You may withdraw your consent at any time. An explanation of your rights is set out below:

For the purpose of the Data Protection Act 1998 up to by not including 25th March 2018, and from then on, The General Data Protection Regulation ("GDPR");

- In respect of the personal data of users of the Website and the services, and business contacts and prospects of Workable, the Data Controller is Onboard Staffing Solutions Ltd. Our nominated representative, as Data Protection Officer for the purpose of Data Protection Legislation, is Michael Green, Finance Manager.
- In respect to Us processing personal information as a data controller, we also process personal information as a Data Processor on behalf of our customers, "the Employer", who use our Services to assist with their recruitment process. Where you are a Candidate or prospective Candidate involved in a recruitment process with an Employer, the Employer's privacy policy may apply to our processing of your personal information instead of, or in addition to, this Privacy Policy.

Definitions

In this policy the following terms shall have the following meanings:

Cookie: a small file placed on your computer or devise by the website when you visit certain parts of the website.

Cookie Law: means the relevant parts of the Privacy and Electronic

Communications (EC Directive) Regulations 2003.

Data Protection Legislation: up to but excluding 25th May 2018, the Data

Protection Act 1988 and thereafter:



- (a) Unless and until the GDPR ((EU) 2016/679) is no longer directly applicable to the UK, the GDPR and any national implementing laws, regulations and secondary legislation, as amended or updated from time to time, in the UK; and then
- (b) Any successor legislation to the GDPR or the Data Protection Act 1988.

Data Subject: a natural identifiable person.

Personal Data: has the meaning set out in the Data Protection Legislation, be at the date of this policy, any data which identifies a natural person (by way of example, name, address, phone number and so on).

What this policy covers:

This policy also explains:

- What personally identifiable information of yours is collected:
 - On the website when you interact with it;
 - When you download from the website;
 - When you interact with the website's advertising & applications on third party websites and services;
- What organisation is collecting the information;

Information we may collect from you

We may collect and process the following information about you:

 Information that you provide by filling in forms hosted by 'The Employer' on the website www.wearelanded.com/careers/companyname (Website). This includes information provided at the time of registering to use the Website, subscribing to our Services, posting material or requesting further information or services.



- We may also ask you for information when you report a problem with the Website.
- Specifically, if you are a Candidate, information relating to your employment history, skills and experience that you upload to the Website, as well as profile photos, links to your social profiles and other publicly available information that we may collect through a third-party service.
- Specifically, if you are a Customer organisation (i.e. an Employer organisation), information regarding job Openings and other details regarding your organisation and its personnel.
- If you contact us for support or general queries, we may keep a record of that correspondence.
- We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- Details of all actions that you carry out through the Website and of the provision of services to you.
- Details of your visits to the Website including, but not limited to, traffic data, location data, weblogs and other communication data, the site that referred you to our site and the resources that you access.

How we store your personal data

We take appropriate measures to ensure that all personal data is kept secure for the duration of your use of our Services.

Unfortunately, the transmission of information via the internet is not completely secure. We will take steps reasonably necessary to ensure that your data is treated securely in accordance with this policy; however, any transmission remains at your own risk. Once we have received your information, we will use strict procedures and security features in order to prevent unauthorised access.

The data we collect from you will not be transferred outside the European Economic Area ("EEA) save in relation to data submitted to our support desk, or data submitted to an Employer knowingly located outside the EEA. By submitting Personal Data, you agree to this transfer, storing or processing.

IP Addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration, customer support and to collect aggregate information for internal reporting purposes. In addition, our Website uses cookies. A cookie is a small file of letters and numbers that we put on your computer if you agree. These cookies allow us to distinguish you from other users of the Website, which helps us to provide you with a good experience when you browse our Website and also allows us to improve the Website.



The cookies we use are "analytical" cookies. Some of the common uses for our cookies are as follows:

- to recognise and count the number of visitors and to see how visitors move around the site when they are using it. This helps us to improve the way our Website works, for example by ensuring that users are finding what they are looking for easily.
- to identify and authenticate a user across different pages of our Website, within our own Website, in a session or across different sessions. This is so that the user does not need to provide a password on every page the user visits; and

Uses made of your information

We use information held about you in the following ways:

Your Rights

 - You wish to withdraw your consent to us holding the data

- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation or in order to enforce or apply our Website Terms and Conditions and other agreements, but we will endeavour to minimise such disclosure to only that reasonably necessary and, where possible, to provide you with notice of such disclosure; and/or
- to protect the rights, property, or safety of Onboard Staffing Solutions Ltd, the Website, our users and any third party we interact with to provide the Website.

Retention and restriction on use of your personal data

Your personal information will be retained until it is deleted. Your personal information will be deleted on one of the following occurrences:

 Request for deletion of your personal information by you (or by another person engaged by the Customer, where you are using the Website and/or Services on behalf of a Customer).



- Where you are a Candidate, deletion of your personal information by an Employer on whose behalf we are processing your personal information.
- Receipt of a written request by you to us.

Where you request in writing that your personal information is not used to enhance the information that we process about you on an Employer's behalf, such enhanced information will not be provided by us to the Employer.

Any request by you to us to delete your personal information will not result in deletion of any application submitted by you to an Employer (in respect of which we are a data processor and not a data controller). If you require an Employer to delete an application, or any other information provided by you to the Employer directly, you must contact the Employer to request such deletion.

Third Party Websites

Email Tracking: some emails that we send have tracking on so that we can tell how much traffic those emails sent to the Website & client application pages. **Suppliers & Other Service Providers:** From time to time we use third party suppliers and service providers to facilitate our services. Where any service provider collects information directly from you, you will be notified of the involvement of the suppliers or service provider, and all information disclosures you make will be strictly optional.

Control of your Password

You must not disclose your LANDED password (Client or Applicant Portal) to any third parties, nor share with any third parties. If you lose control of your password you may lose control over your Personal Data which in turn may commit you to legally binding obligations without your consent.
